

# Rosa's London Limited– “Win a Free Trip to Thailand” Competition

## Terms & Conditions

### 1. Promoter

The promoter of this competition is **Rosa's London Limited** (“Rosa's Thai”).

### 2. Eligibility

- The competition is open to residents of the United Kingdom aged **18 years or over** at the time of entry.
- Employees of Rosa's London Limited, its agents, affiliates, or immediate family members are not eligible to enter.
- Entry is subject to these Terms & Conditions.

### 3. How to Enter

- To enter, customers **must book a table at any participating Rosa's Thai restaurant between Wednesday 1<sup>st</sup> April – Thursday 30<sup>th</sup> April 2026**.
- Customer must complete booking and visit Rosa's Thai during April 2026 for the entry to be valid.
